ADMINISTRATIVE LAW

Duty to give reasons - claim for non-refoulement - Torture Claims Appeal Board - appeal against dismissal of claim - late filing of Notices of Appeal as claimants' duty lawyer on maternity leave - refusal by Board for late filing - no statutory duty to give reason for preliminary decision under s.37ZT - fairness required Board to give reasons for refusal - Immigration Ordinance (Cap.115) s.37ZT, s.23 of Sch.1A

B v Torture Claims Appeal Board, HCAL 80/2014, 6 January 2015, CFI (Thomas Au J); [2015] 1 HKLRD 681.

COMPANY LAW

Unfair and prejudicial conduct - respondent investor directed affairs of free television station through majority shareholder - whether proper regard to petitioner's rights, proper corporate practice and requirements of free television station licence - appropriate relief in light of recommendation by Communications Authority that licence not be renewed

LAND LAW

Title/sale of land - forfeiture of deposit - deposit exceeded conventional 10% of purchase price - longer than usual completion period constituted exceptional circumstances justifying forfeiture of higher amount.
