### Constitutional and Administrative Law

ZN v Secretary for Justice, HCAL 15/2015, 13 November 2015, CFI (Zervos J); [2016] 1 HKLRD 174

#### **PHRASES**

Courts and judicial system - judges - recusal - hearing of application for judicial review involving issue of human trafficking - whether judge to be recused by reason of positive stance he took in combating human trafficking when he was Director of Public Prosecutions - application for recusal by Government should be rare and made only in most obvious cases - no real possibility of apparent bias

#### APPLICATION

This was an application by the respondents, namely the Secretary for Justice, the Director of Immigration, the Commissioner of Police and the Commissioner for Labour seeking that the Judge dealing with a judicial review recuse himself because of the stance he had taken when he was the Director of Public Prosecutions.

#### **PHRASES**

Company law - winding-up - petition - foreign company - approach to appropriate jurisdiction - Companies (Winding Up and Miscellaneous Provisions) Ordinance (Cap.32) s.327 Company law - liquidation - foreign company - Hong Kong court empowered at common law to recognise and assist foreign liquidators

#### APPLICATION

This was an application by the petitioner to wind up a foreign company listed in Hong Kong and the early hearing of an application to appoint provisional liquidators.

#### **PHRASES**

Tort - negligence - causation and remoteness - sick role - injured plaintiff adopted sick role but not malingerer - plaintiff's personality caused him to adopt sick role and accident had not changed his personality - accident had not adversely affected his personality - not "thin skull" case - defendant not liable for losses flowing from sick role Damages (Personal injuries or death) - feet - crush injury - fracturedbig, second and third right toes - residual pain and stiffness in foot - post-traumatic stress disorder - adoption of sick role - 29-year-old apprentice vehicle mechanic

#### APPEAL

This was an appeal by the plaintiff in a personal injury action against the defendants, Lai Ping Wai and Wu Kwai Ming Danny, formerly trading in partnership in the name of Elegant Motors Service Co, in respect of damages awarded by Bharwaney J on 7 November 2011 (see [2012] 1 HKLRD 1)



## Westlaw Searching Skill Searching

Do you have difficulty searching cases or other legal materials on Westlaw? The following tips may help you to find what you are looking for quicker:

### Go to the tab

You will see a search box right after you log in to your Westlaw account. However, if you are certain about the nature of material you are going to search, you can go to the specific tab on the upper part of the page. This can effectively limit your search to a certain part of the Westlaw database.

# Use logical connectors wisely.

It is not always the case that you will have a particular case in mind. You may be undergoing a research or doing a general analysis on an area of law. Here, logical connectors will be very helpful. A very important connector will be the quotation marks "". If you put a phrase inside the quotation marks, the system will only return those documents where the search terms appeared in the exact same order in those documents. Another useful connector is the percentage sign (%). % means "but not", so if you search "taxation % income", the system will return all results with the word "taxation" but not the word "income". This may be slightly risky in excluding useful documents, but is definitely a useful connector to refine your search if you are searching for a less prominent area of law.

## 2. Use different boxes.

This is especially true when you are searching for cases. Instead of typing broad terms in the "free text" search box, try the other ones. For instance, if you have the citation of a particular case with you, just type the citation in the "citation" search box.

Even if you don't have the citation but have the party names, you should try to put the party names in the "party names" search box. If you typed them in the "free text" search box, it will basically return all cases that cited the case. Take Donoghue v Stevenson as an example; the "free text" search will result in at least 1,376 cases, while the "party names" search will only result in 2 cases: one of them is what you want.

Exclamation mark (!) is a root expander which can help you search for words with multiple endings. For example, object! will return documents with terms object, objected, objection, objecting and objectionable.
