

CASE LAWS UPDATE

Tort Law

Lam Pak Keung v Ip Tsz Ping [2016] 3 HKLRD 139

Duty of care – D3 lessee of freight terminal where it carried out logistics business – subcontracted most operations to D2 – D2's employee struck by forklift truck driven by fellow employee - whether D3 liable

Land Law

Tang Kai Tung v Tang Wai Lun [2016] 3 HKLRD 96

Adverse possession – limitation – application to tso land – whether limitation had run against all members of tso – whether time stopped running during period of previous action against tso on basis tso raised its right to recover land in that action

Criminal Law

HKSAR v Chan Chi Wan Stephen [2016] 3 HKLRD 186

corruption and bribery offences – accepting advantage as agent – offering advantage as agent – conspiracy for agent to accept advantage – elements of offences – defence of reasonable excuse – scope – distinction between defences of reasonable excuse and permission – applicability where employee accepted secret reward for outside work engagement related to principal's business
