## CASE LAWS

#### Tort Law <u>Sum Cheung Wai v Tsui Hin Yuet [2016]</u> <u>4 HKLRD 742</u>

Malicious prosecution - prosecution - no prosecution where no charge laid against plaintiff - police exercised independent judgment and discretion in investigation of report of crime - defendantcomplainant not "prosecutor"

#### Land Law

Wan Po Jun Mary Pauline v Au Yeung Yee Man [2017] 1 HKLRD 94

Beneficial ownership - bankrupt claiming right to occupy property based on constructive trust - right immediately referable to alleged interest as beneficial owner of property - claim vested in trustees in bankruptcy - right to defend counterclaim could not be segregated from beneficial interest in property and separately assigned by trustees

#### Criminal Law

HKSAR v Chang Wai Hang Alab [2017] 1 HKLRD 163

Appeal - abandonment of appeal application to treat abandonment of appeal against conviction as nullity where erroneous advice led to belief sentence might be affected if insisted on appeal, court could treat abandonment as nullity - whether applicant misled whether belief reasonable or credible
