## BASIC SEARCH ON NETWORKED CD-ROM

- ① Type your search term(s)
- ② Set search parameters, if necessary
- ③ Click SEARCH to perform search

## SETTING SEARCH PARAMETERS

Search parameters	Functions / To search for	Examples
• Exact entry	to search for exactly what you have typed in	judicial review duty of care power of attorney
• Composite entry	to search using any or a combination of search connectors, wildcards or proximity operator	
<i>Connectors</i> and	to search terms together automatically without adding AND	solicitors misconduct
or	to locate one term or the other	solicitors <b>or</b> barristers
not	to exclude documents with search term following <i>not</i>	solicitors <b>not</b> barristers
<i>Wildcards</i> *	to replace <i>multiple characters</i> in a word; can be used <i>twice</i> only in any one search string	judicia* injur*
?	to replace any <i>single character</i> in a word	wom?n
<i>Proximity operator</i> adj[n]	terms within "n" terms of each other ( <i>n is a number</i> )	solicitor* <b>adj10</b> misconduct <b>and</b> conveyanc* mens <b>adj</b> rea <b>adj5</b> manslaughter
• all text	to search entire content of each document	original title deeds
• catchwords	to search only the headnote/keyword area of each document	indecent article* conveyancing and property ordinance

• 1905-2004	to specify a range of dates between 1905 & the most current reports available in the database	1905 to 2004

## VIEWING THE RESULTS OF YOUR SEARCH

- ▶ Use scrollbar or ↑↓ arrows to browse the list
- ▶ To view a document, click on the document of interest
- ▶ Click on FIND button to search for words within the displayed document
- ▶ Click on FULL button (if available) to display the full judgment
- ▶ Click on DIGEST button (if available) to re-display facts/digests of the document
- ▶ If you highlight some text in the viewer, click on Go To button to search for other documents containing the highlighted text

## SAVING/PRINTING RESULTS

To save to disk, specify drive, file name, file type (prefer Rich Text Format).

| To save/print a <b>document</b>         | ▶ from the Document Viewer window, click SAVE or PRINT |
| To save/print the <b>Search Result</b>  | ▶ from the Search Result window, click SAVE or PRINT   |
| To save/print the <b>Bookmarks List</b> | ▶ from the Bookmarks window, click SAVE or PRINT       |
| To save/print <b>Backlist</b>           | ▶ from the Backlist window, click SAVE or PRINT        |

## USEFUL FEATURES

- BOOKMARKS**
- ▶ You must be viewing a document
  - ▶ Click on the BOOKMARKS tab
  - ▶ Click on ADD button to add new bookmark, click on REMOVE OR REMOVE ALL button to remove selected bookmark or clear the entire bookmarks list
- BACKLIST** keeps track of the documents you have viewed within a search session
- ▶ Click the DOCUMENT VIEWER tab
  - ▶ Click on BACKLIST button and the Backlist dialog box will appear
